Whereas, Sh. Nazir Ahmad Magrey, Assistant Town Planner (Tourism), Town Planning Organization, Kashmir applied for grant of one month's earned leave w.e.f. 05.03.2019 and the Chief Town Planner, Kashmir vide communication No. PF/ATP/CTPK/19/425-26 dated 22.02.2019 recommended his case to this Department for grant of permission in your favour to visit USA to meet his Son;

Whereas, he left the country without obtaining the proper permission from this department despite being figured in case FIR No. 27/2008 P/S VOK as per report of General Administration Department (Vigilance Section)'s OM No. GAD(Vig)06-NOC/2017-HUD dated 10.07.2017;

Whereas, as per Government instructions such permission is covered under extant regulation including those contained in Circular issued by the Finance Department vide No. A/46(2017)-1-862 dated 21.02.2019;

Whereas, vide this Department's letter No. HUD/TPO/15/2016 dated 26.12.2019 and 15.01.2020, he was directed to explain his position for leaving the country without proper permission from the Government;

Whereas, he has cited personal reasons for the visit to USA within the specified months of March, 2019.



In view of his submission, ex- post facto sanction for permission w.e.f. 05.03.2019 to 28.04.2019 is granted in his favour in connection with his visit to USA. However, he is warned to remain careful in future and not to leave the station without prior permission/approval of the Competent Authority.
