Sanction is hereby accorded to the release of funds amounting to **Rs. 125.00 Lakh (Rupees One Crore and Twenty Five Lakh)** only in favour of **Vice Chairman, Srinagar Development Authority and Jammu Development Authority** under Urban Development Sector of State Capex Budget 2018-19 as an additionality released by the Finance Department Expenditure Division II in Revised Estimates of 2018-19 to be utilized for execution of following works to the extent of amount shown against each as detailed here under during Current Financial Year 2018-19.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of Vice Chairman, JDA/SDA.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- ii. the funds so released shall be utilized for the activities specifically provision for; after completion of all the codal formalities/procedures as required under rules and shall not be available for re-appropriation/diversion at any level, besides the expenditure shall not be utilized on Revenue or Revenue like items;
- iii. the vetted cost of each component/activity shall not be exceed in any case and all the necessary clearances/approvals shall be sought from the competent/regulatory Authority before implementation of the scheme;
- iv. Drawing and Disbursing Officers shall satisfied themselves about the responsibilities of cost, proper quality control, genuineness of workdone claims and physical existence of works;
- v. the implementing agency shall ensure that, reasonability of rates and complete the project within the approved cost only and there should be no cost overrun/time overrun;

- vi. the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- vii. the Director Finance, H&UDD shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- viii. the Utilization Certificate of the amount is rendered to the concerned quarters within a stipulated time;
- ix. Utilization Certificate for the amount shall be furnished immediately for availing the 2nd instalment;
- x. The implementing agency shall ensure that, all codal formalities including AAA, e-tendering shall be strictly followed;
- xi. all video graphic/photographic evidence of works both shall be maintained;


