Whereas, Housing & Urban Development Department, Government of Jammu and Kashmir vide S.O 90 dated 14th March, 2022 declared 12 villages along with Khasra number of Tehsil Akhnoor & 11 villages along with Khasra number of Tehsil Bhalwal to be local area under the Jammu & Kashmir Development Act, 1970 and has constituted an authority to be known as **Akhnoor Development Authority** under the Chairmanship of Chief Secretary, J&K;
