S.O 259.— In exercise of the powers conferred by section 280 read with section 12 of the Jammu and Kashmir Municipal Act, 2000, the Government, make the following amendments in the Jammu and Kashmir Municipality (Reservation of offices of Chairperson) Rules, 2005; namely:-

1. In rule 2;

- (i) in clause (a), for the words "Scheduled Castes and Scheduled Tribes", the words "Scheduled Castes, Scheduled Tribes and Other Backward Classes" shall be substituted.
- (ii) in clause (b), for the words "Scheduled Castes and Scheduled Tribes", the words "Scheduled Castes, Scheduled Tribes and Other Backward Classes" shall be substituted.
- (iii) in clause (c), for the words "Scheduled Caste and Schedule Tribe", the words "Schedule Caste, Schedule Tribe and Other Backward Classes" shall be substituted.

2. In rule 3;

- in clause (a), for the words "Scheduled Castes and The Scheduled (i) Tribe", the words "Scheduled Caste, Scheduled Tribe and Other Backward Classes" shall be substituted.
- after the table, the following note shall be added; namely:-(ii) "Note: The reservation for different territories provided in this rule shall be allocated accordingly with respect to Scheduled Caste/Scheduled Tribe and Other Backward Classes."
