**THE JAMMU AND KASHMIR MUNICIPAL CORPORATION
(AMENDMENT) ACT, 2018**

(Governor Act No. XXXVIII of 2018)

An Act to amend the Jammu and Kashmir Municipal Corporation Act, 2000.

In exercise of the powers vested under Proclamation No. P-1/18 of 2018 dated 20th of June, 2018, the Governor is pleased to enact as follows :—

1. *Short title and commencement.*—(1) This Act may be called the Jammu and Kashmir Municipal Corporation (Amendment) Act, 2018.

(2) It shall come into force from the date of its publication in the Government Gazette.

2. *Amendment of section 40, Act XXI of 2000.*—In section 40 of the Jammu and Kashmir Municipal Corporation Act, 2000,—

(I) in sub-section (1),—

(i) in clause (c) the word “and” shall be deleted.

(ii) in clause (d), the sign full stop (.) shall be substituted by sign semi-colon (;) and thereafter the following clauses shall be added, namely,—

(e) Housing for All Committee ;

(f) Skill Upgradation and Self-Employment Committee ; and

(g) Swacch Bharat Committee.”

(II) after sub-section (6), the following sub-sections shall be inserted, namely :—

(6A) The Housing for All Committee shall perform functions related to monitoring and review of progress under the Prime Minister Awas Yojana.

(6B) The Skill Upgradation and Self-Employment Committee shall perform functions related to monitoring and review of progress under the National Urban Livelihood Mission.

(6C) The Swacch Bharat Committee shall perform functions related to monitoring and review of progress under the Swacch Bharat Mission.”

(III) for sub-section (7), the following sub-section shall be substituted namely,—

“(7) The Mayor shall be the ex-officio member and also the Chairman of the General Functions Committee and the Finance and Planning Committee. The Deputy Mayor shall be the ex-officio member and also the Chairman of the Housing for All Committee and Skill Upgradation and Self-Employment Committee.”
