ORDER

Whereas, as per section 85 of J&K Municipal Corporation Act, 2000, the Corporation may levy fee with regard to maintenance of civic amenities in its limits.

Whereas, Jammu Municipal Corporation in the 47<sup>th</sup> meeting of General House held on 6.4.2009 decided to levy sanitation charges @ Rs. 50/- per month in Ward No. 20, 21, 22, 52, 53, 54 & 69 and accordingly the same was levied vide Order No. MJ/Estt/3181-87 dated 30.7.2009.

Whereas, JMC intends to impose user charges (Sanitation/Solid Waste Lifting and Disposal Charges) in all the 71 wards of the Corporation as part of mandatory urban reforms to be undertaken by the Corporation.

Whereas, Housing & Urban Development Department has conveyed the Cabinet decision No. 68/7/2011 dated 18.3.2011 vide No. CEO/ \*SUDA/ 305/2010 dated 20.3.2011 which is reproduced as below:-

"Further, the cabinet desired that other pending measures connected with the mandatory Urban Local Bodies reforms be expedited, so that the current bottlenecks in the release of central funds are removed".

Whereas, the Health Officer, JMC has initiated a proposal for levying of user charges in all the 71 wards of JMC @ Rs. 100/- in respect of ward Nos. 20, 21, 22, 50, 53, 54, 62, 68, 69, 70 & 71 per house hold per month and Rs. 50/- per house hold per month in respect of rest of the wards of Corporation.

Now, therefore, in view of above, the user charges (Sanitation/Solid Waste Liiting and Disposal) are hereby extended in all the 71 wards of the Jammu Municipal Corporation as detailed below:-

Ward No.	User Charges
20, 21, 22, 50, 53, 54, 62, 68 to 71.	Rs. 100/- per house hold per month.
Other Wards viz. 1 to 19, 23 to 49, 51, 52, 55 to 61, 63 to 67	Rs. 50/- per house hold per month.

However, in respect of households of persons falling in the category of "Below Poverty Line and residing in Slums" are exempted from the user charges.

This order shall come into force with immediate effect.
